\*Rules and regulations: \$120 minimum donation to United Way of the Wine Country (UWWC) required for the opportunity to enter the drawing. Past donors must increase their annual contribution by 10% over the previous year's contribution, for a minimum total of \$120. Employees (and their immediate family members) of Hansel Auto Group and UWWC and not eligible. UWWC Board members are not eligible. Donors whose contributions are made through third-party processors are ineligible if the third-party processor does not provide donor details to UWWC. Void where prohibited. Entrants must be legal residents of the continental U.S., at least 18 years of age with a valid driver's license and able to present evidence of adequate insurance. Winner subject to verification of compliance with rules and will be required to execute liability release and affidavit of eligibility/publicity release. The vehicle will be given away at the UWWC Campaign Close Celebration (June 2010, exact date TBA). Qualified participants will receive an entry form by April 30, 2010. The vehicle shall be delivered at the location of Hansel Auto's choosing and within delivery period as designated by UWWC and Hansel Auto.
